

### Opinion



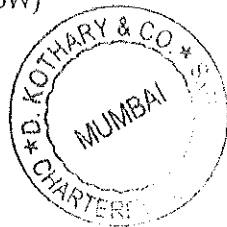
